Tuition and Fees:

Tuition: \$2,300

Registration Fee: \$250 (+ \$250 Deposit applied to tuition)

Total Program Cost: \$2,550 (with payment Option 1)

Tuition Payments:

Tuition deposit of \$500 is due with signing of the enrollment agreement. A non-refundable registration fee of \$250 is already included in this down payment. Lotus Yoga KC will require a Credit Card or Debit Card to be on file for your account.

Payment Options:

Option 1: Down payment of \$500 and the balance to be paid by the start of the program.

Option 2: Down payment of \$500 and three installment payments of \$716.67 each to be paid by October 15<sup>th</sup>, 2019, by February 15<sup>th</sup>, 2020, then a final payment is due by May 15<sup>th</sup>, 2020. Total paid \$2650.

Option 3: Down payment of \$500 and monthly installments due on the 15<sup>th</sup> of each month of \$250 will be charged to Credit Card or Debit Card on file. Total paid \$2750.

*Cancellation and Refund Policy Prior to Program Start date:*

Enrollment Denials: An applicant denied admission by the school is entitled to a full refund of all monies paid.

3-Day Cancellation: An applicant who submits written notice of cancellation within 3 business days of signing the enrollment agreement is entitled to a refund of all monies paid. No later than 30 days of receiving the notice of cancellation. Lotus Yoga KC Teacher Training will provide a 100% refund. The 3 Day Cancellation Rule excludes, Saturday, Sunday and Federal and State holidays.

Other Cancellations: An applicant who submits written notice of cancellation of the program more than 3 business days after signing an enrollment agreement and making an initial payment, but prior to entering the school (start of the program) is entitled to a refund of all monies paid less the \$250 registration fee.

Refunds After the Program Start Date: Procedure for withdrawal and withdrawal date:

A student choosing to withdraw from the program after the start date is to provide written notice to the Director of Lotus Yoga KC Teacher Training. The notice is to indicate the expected last date of attendance and be signed and dated by the student.

For a student who is on authorized Leave of Absence, the withdraw date is the date the student was scheduled to return from the leave and failed to do so.

A student will be determined to be withdrawn from the institution if the student has not attended any classes for 30 consecutive days.  
All refunds will be issued via check within 30 days of the determined withdraw date based on the terms above.

After the commencement of classes, the tuition less the registration fee of \$250 shall be determined as follows:

% of clock hours at the withdrawal date:	Refund amount
10% or less	90% Refund
More than 10% and less than or equal to 20%	80% refund
More than 20% and less than or equal to 30%	70% refund
More than 30% and less than or equal to 40%	60% refund
More than 40% and less than or equal to 50%	50% refund
More than 50%	No refund is required

The percentage of the clock hours attempted is determined by dividing the total number of clock hours elapsed from the student's start date to the student's last date of attendance, by the total number of clock hours in the program (less the \$250 registration fee).

Books, Workshops, Supplies and Fees: There is no refund for equipment, books or supplies received by or purchased by the student. Any workshops paid for and attended by the student are not refundable.

Special Cases: In the case of prolonged illness, death in the family or other special circumstances that make it impractical for the student to complete the program, the school may make a settlement that is fair and reasonable.
